Behavioral Skills	<ul style="list-style-type: none"> <li>Ability to exhibit professional behaviors in the work environment.</li> </ul>	<ul style="list-style-type: none"> <li>Be accountable for schedules and work performance.</li> <li>Demonstrate initiative, flexibility, enthusiasm, honesty, and cooperative behavior.</li> <li>Perform duties efficiently, willingly, and thoroughly.</li> <li>Present professional appearance and maintain personal hygiene.</li> </ul>

<p>Communication Skills</p>	<ul style="list-style-type: none"> <li>• Possess adequate comprehension and understanding of the English language in spoken, written, and nonverbal formats.</li> </ul>	<ul style="list-style-type: none"> <li>• Effectively communicate with people of all ages by giving information/directions and advising of rights/processes.</li> <li>• Prepare investigative and other reports using appropriate grammar, symbols, and mathematical computations.</li> <li>• Prepare and process such documents as citations, affidavits, and warrants.</li> <li>• Communicate effectively and coherently over law enforcement radio.</li> <li>• Recognize, interpret, and respond to nonverbal behavior of self and others.</li> <li>• Resolve conflict in a calm, non-defensive, and respectful manner.</li> <li>• Demonstrate communication skills in court and other formal settings.</li> </ul>
<p>Critical Thinking Skills</p>	<ul style="list-style-type: none"> <li>• Ability to collect, interpret, and integrate information and make decisions within a range of function.</li> </ul>	<ul style="list-style-type: none"> <li>• Read and comprehend relevant information in textbooks, statutory/case law, legal/non-legal documents.</li> <li>• Exercise independent judgment in determining when there is reasonable suspicion to detain, when probable cause exists to search and arrest, and when force may be used and to what degree.</li> <li>• Detach from individual prejudices and assumptions to make informed decisions in high and low stress situations.</li> </ul>
<p>Interpersonal Skills</p>	<ul style="list-style-type: none"> <li>• Ability to work collaboratively with others.</li> </ul>	<ul style="list-style-type: none"> <li>• Interact appropriately with individuals from a variety of social, emotional, cultural, and intellectual backgrounds.</li> <li>• Ability to listen to others and determine their needs and wants.</li> <li>• Ability to employ basic conflict management skills.</li> <li>• Endure verbal and mental abuse when confronted with hostile views and opinions of other people in an antagonistic environment.</li> </ul>
<p>Mobility and Motor Skills</p>	<ul style="list-style-type: none"> <li>• Adequate ability to perform physical requirements.</li> </ul>	<ul style="list-style-type: none"> <li>• Operate a law enforcement vehicle during all times of the day, in all types of conditions, in emergency and non-emergency conditions.</li> <li>• Physical capability to run, walk/stand for long periods of time, climb, manipulate, heavy objects, crawl, and use body strength to gain entry through barriers.</li> <li>• Proficiency with firearms at levels prescribed in certification standards.</li> </ul>
<p>Tactile Skills</p>	<ul style="list-style-type: none"> <li>• Ability to detect faint vibrations, temperature differences, and texture differences that may assist in collecting evidence.</li> </ul>	<ul style="list-style-type: none"> <li>• Perform searches of people, vehicles, buildings, and large outdoor areas which involve feeling and detecting objects.</li> </ul>

Visual Skills	<ul style="list-style-type: none"><li>• Possess sufficient eyesight to read documents and records.</li></ul>	<ul style="list-style-type: none"><li>• Conduct visual surveillance for extended periods of time.</li></ul>
